If student proof is not submitted dependent child will cease to be a member of the club and a separate application will have to be submitted as a new member.
- Member seeking own individual membership at current discounted rates, must have been a child member of age 16 years or less at time of joining under family membership. Granting of individual membership to dependent children will be considered only on attaining age of 21 years.
