## 5.0 REQUIRED DOCUMENTS

## 6.0 PROCEDURE FOR SUBMISSION

- 6.3 Applications that are incomplete shall be returned for resubmission with the required information / documents.

### 7.3 Cover Charge

Cover Charge payable quarterly is charged when a member does not utilize Food & Beverage beyond Rs.3,475/= per quarter.
