- 9.3 Applications that are incomplete shall be returned for resubmission with the required information / documents.

10.0 CHARGES

10.2 Refundable Deposit

The temporary member is required to deposit a minimum of Rs. 10,000 in order to avail themselves of all F & B and other services. Such services will be available upto the value of the deposit. All unused funds will be refunded when the membership ceases to be valid.

11.0 GUEST RULE

No person shall be admitted to the Club as a guest more than twice in one month or more than six times in one year. Children are not permitted to sign in guests. All guests charges as per the rules shall be applicable.
