# 6.0 PROCEDURE FOR SUBMISSION

6.1 Duly completed application to be submitted to the Member Relations Executive during office hours, Monday to Saturday.

6.2 On receipt of a perfected application the Member Relations Executive will issue a note confirming receipt by the Club of the application.

6.3 Applications that are incomplete shall be returned for resubmission with the required information / documents.

6.4 Submission of an application does not guarantee membership nor a call for an interview.

6.5 The CSC as a matter of practice does not officially comment on and /or correspond regarding the status of any pending membership applications. Any inquiries regarding the status of applications is discouraged and canvassing in any form will be a disadvantage to the applicant.

# 7.0 CHARGES 7.1 Joining Fees Spouse Rs. 180,000 Entrance fees paid shall not be refundable. 7.2 Annual Subscription Spouse : Rs. 13,500 Cover Charge Cover Charge payable quarterly is charged when a member does not utilize Food & Beverage beyond Rs.12,000/= per quarter. Amount payable is calculated as the difference between Rs. 12,000/- and the amount utilized for food and beverage during the quarter. Calculation of cover charge will be independent for each quarter.

### 8.0 GUEST RULE
